1.2 Worldwide School reserves the right to modify its course

arrangements and to alter its specifications without prior notice.

2. FEES

- 2.1 Fees must be paid in advance, and in full, along with four weeks advance payment for homestay accommodation.
- 2.2 Fees paid cannot be refunded, except described here.
- 2.3 All fees and homestay accommodation payments are calculated in complete weeks and any part of a week is counted as full week. No compensation can be given for any days when school is closed due to public holidays.
- 2.4 In the event of late arrival, absence or early departure from a course, no refund of fees or free extension of the course can be granted.

3. CANCELLATION AND REFUNDS

3.1 If a cancellation is made at least two weeks before the course is due to commence, or if a visa is not granted, or if a cancellation is made within the first seven days of a course longer than 12 weeks, payment shall be returned in full less a cancellation fee of NZ\$ 500 or 10% of the total amount paid (whichever is lesser). If a cancellation is made thereafter no refund shall be paid. No refund will be made for a course of less then 12 weeks after the course has commenced.

3.2 Worldwide School is member of CRELSNZ. All CRELS members are bound by the constitution to support student affected by the closure of a member school by providing similar tuition at no extra cost to the student.

4. COURSE CHANGES

4.1 No changes can be made to courses once the course has commended

5. ACCOMMODATION

- 5.1 Changes of accommodation can be made only after 14 days notice.
- 5.2 If suitable notice is not given, two weeks accommodation must be paid in lieu. Temporary absence during a course does not cancel the obligation which must still be for at the full rate.
- 5.3 Accommodation fee not already paid will be paid four weekly in advance
- 5.4 Accommodation pre-paid for the first four weeks cannot be refunded.

6. SCHOOL RULES

6.1 Should a student not comply with the School Rules and the laws of New Zealand, or fail to attend the course in which he/she is enrolled, the school reserves the right to expel the student, and is legally bound to advise the NZ Immigration Service.

7. LIABILITY & INSURANCE

- 7.1 Worldwide School shall not be liable if the service contracted for cannot be provided for reasons beyond its control.
- 7.2 The student must undertake his or her own insurance against personal accident or illness. Worldwide Scholl can arrange this through its health insurance company. Details are available on request.
- 7.3 Students are advised to arrange personal insurance against theft, loss of, or damage to personal property, as neither the school nor the host families can be held responsible for any injury, damage or lost incurred.
